

Privacy Statement for the Butler County Domestic Relations Court Website

Butler County Domestic Relations Court operates a website on the Internet in order to provide services to the residents of the County. In providing these services, information about visitors to a website may be collected automatically or may be submitted by the website user. Butler County Domestic Relations Court recognizes the public's concerns about privacy on the Internet.

Notice / Awareness

Information Collected Automatically about the Computer Which Browses, Downloads Information from this Website, and Cookies Set by this Website.

We may collect and store information for statistical purposes. For example, we may count the number of visitors to the different sections of our site to help us make them more useful. This information does not identify you personally. The following information is automatically collected by your browser and is submitted to our server and is stored about your visit:

- The Internet domain (for example, mycompany.com if you use a private Internet access account, or yourschool.edu if you connect from a university's domain) and IP address (an IP or Internet Protocol address is a number that is automatically assigned to your computer whenever you are connected to the Internet) from which you access our website;
- The type of browser and operating system used to access our website;
- The date and time you access our website;
- The pages you visit; and
- The address of the website which referred you to our website, for example a search engine or link from another website.

We use this information to help us make the site more useful to visitors - to learn about the number of visitors to our website and the types of technology our visitors use.

We occasionally use cookies to customize your visit to our website. Cookies are text files created by your browser, and they provide a method of distinguishing among visitors to our website. Cookies are stored on your computer and do not contain personally identifiable information. We use the cookie feature to store a randomly generated number that relates back to the preferences you make about an application on our server - for example, to search by parcel instead of by address. You can refuse the cookie or delete the cookie file from your computer at any time by using the tools provided by your browser or a third party piece of software. Your choice to refuse the cookie will not inhibit your access to any of the information available on the Butler County Domestic Relations website. Your acceptance of the cookie will serve to provide you with additional functionality in choosing the information you wish to view on a regular basis.

Personally Identifying Information Collected from E-mails or Web Forms

By sending us e-mail (electronic mail message) or filling out a web form, for example, a Contact Us form, you are sending us personal information (i.e., your name, address, phone number, e-mail address or other information). We store this information in order to respond to or process your request or otherwise resolve the subject matter of your submission.

Information Subject to Disclosure Under the Public Records Act or Other Legal Requirements

Visitors should be aware that, subject to certain statutory exceptions, most documents and records are maintained by Butler County Domestic Relations Court, including but not limited to electronic data, are public records under Ohio Law. Therefore, information submitted through this website may be subjected to disclosure pursuant to a public records request.

Our website contains links to information and services located on websites maintained by other public agencies and private organizations. Sharing Information with other Butler County Domestic Relations Court Departments or Agencies to Provide Services

We may share personally identifying information with other Butler County Domestic Relations Court departments or agencies in order to respond to your request.

If you choose not to provide us with your name or other information, it may be impossible for us to refer, respond to, or investigate the issue you are concerned about.

Getting Access to Information and Providing Corrections

Contact this department through the e-mail address/telephone number noted on our website and make a specific request for a copy of the information we have received online from you and have stored. If you find that this information is inaccurate or incomplete, you may provide us with verified accurate and complete information.

Integrity/Security

Information Transmitted by E-Mail Is Not Secure from Interception

Secure Transmission of Information

Butler County Domestic Relations Court maintains a secure server for the express purpose of collecting personal information from site visitors through an encrypted connection by using Secure Sockets Layer software (SSL) to the Internet. This server can be identified by address <https://secure.butlercountyohio.org> or by tools built into your browser. For example, a lock will appear in the lower corner of your browser during such secure connections. Your connection is not secure if the lock in the lower corner is not present.
